



MediCare Supplement Trust Fund Premium Assistance Program

The 2021 disbursements remain the same - \$115.00 for the Retiree and \$57.50 for the Surviving Spouse. According to the participating numbers on 9/22/2020 we had 89 Retirees and 19 Surviving Spouses enrolled in the program, as we move along in the coming year those numbers change due to members retirement and deaths by the end of this month (Feb. 2021) we would have 89 Retirees and 16 Surviving Spouses that are eligible/participating in the MCSTF Program. As you can see the numbers fluctuate during the year. Coming in March we could add 2 more Retirees to the total number. As the 2021 year progresses we will add a total of 12 eligible retirees by year's end.

Here's what's happening in the lives of our members.

Condolences to **retired LT David Pyle** on the loss of his mother, Mary Jane Pyle, who passed away unexpectedly at the age of 76 on January 22 while battling cancer.

Retired FF David VanDyke (#1791), age 90, passed away at home on January 22 with his wife of 70 years and family at his side. Firefighter VanDyke was hired July 30, 1952 and retired October 22, 1963 to pursue a career as a builder/developer. There will be a visitation at 13:30 hours on Friday, January 29 at Vineyard North Church, 4700 E. Beltline Ave. NE. The funeral will follow at 15:00 hours.

UPDATE: Retired FF Kurt Kolenda continues to recover at home. During follow ups with his medical team last week, his surgeon was pleased with his physical progress and felt that he was slightly ahead of where he should be at this point. Unfortunately, his MFB doctors said his neurological function is not where they'd like it to be. He still has very limited feeling from his naval to his knees, including bowel function. There is no change to his prognosis and he is still looking at 15-months before his physical healing is complete. There is an effort afoot to provide snow removal for the Kolendas this winter. Accidents & Injuries with Horses

Annual Report - May 1, 1883 thru April 30, 1884

Assistant Fire Marshal Solon Baxter broke his collarbone when his horse fell responding to an alarm of fire. Engineer Thomas Gibbons Steamer Company #2, injured his hand while hitching his teams of horses.

April 29, 1890

Lineman Allen Lamb, Alarm Division, injured after being thrown from a line wagon while it's horse was running away.

August 13, 1901

Pipeman Thomas Fitzpatrick, Hose Company #7, was thrown from his exercising wagon and struck his head and shoulders, bruised the right side of his face and sprained his right ankle. He was off duty for 9¼ days.

August 25, 1901

Driver J. B. Taylor, Hose Company #2, injured his foot when it was struck by a whiffletree chain strap. He was off duty for 7 days.

December 24, 1901

Driver Henry P. Beckwith, Steamer Company #2, had two ribs broken when a horse pushed him against a wall in the stable. He was off duty for 10 days.

December 8, 1902

Lieutenant John Younglove, Hose Company #4, was hit in the eye by a piece of steel from a horseshoe calk. The injury caused a cataract in the eye that required an operation. He was off duty 38 days.

January 23, 1904

Lieutenant Joseph A. Brown, Hose Company #8, had bones in his foot injured while getting his team of horses out of a hole filled with snow. One of the horses struck his foot but he remained on duty.

January 25, 1904

Driver Will Baker, Chemical Company #1, got bit on the face by a horse while doing work in the stable but he remained on duty.

February 8, 1904

Substitute Driver Tony DeHoes, was injured about the head and face after being thrown from the exercising wagon while exercising the steamer team. He was off duty for 4 days.

July 1, 1904

Pipeman John Miller, Hose Company #2, had his head injured. While riding a horse out of the barn the horse jumped up striking Miller's head against the frame of the barn door. He was off duty for 4 days.

July 22, 1904

Driver Peter Wieland, Hose Company #3, was kicked in the leg by a horse and was off duty 2 days recovering from the injury.

January 7, 1907

Driver Michael Murphy, Steamer Company #3, had his foot broken when one of his team of horses stepped on it in front of the station. He was off duty 42½ days.

October 10, 1907

Driver Charles Shook, Steamer company #5, was kicked by a horse in the station and went off duty for 8 days to recover from the injury.

November 8, 1909

Pipeman Richard Duerloo, Engine Company #2, was injured when the Fire Marshal's buggy ran over him as he attempted to stop the horse when it became frightened leaving the station. Duerloo was quite badly hurt but remained on duty.

December 7, 1911

Driver James Carey, Engine Company #4, had his eye injured by a cinder that was thrown by the horses he was exercising. He was off duty for 9 days.

October 15, 1912

Assistant Engineer Charles Seydel, Steamer Company #11, was badly shaken up and bruised his hands and limbs when a team of horses he was exercising became frightened by a street roller and ran away, but he remained on duty.

February 12, 1913

Lieutenant Samuel Pomeroy, Steamer Company #11, while responding to an alarm at Box 247, was thrown from Hose Wagon #11 at the corner of Lake Drive and Diamond Street and received a severe scalp wound but he remained on duty.

June 28, 1913

Driver Dewitt C. Stapleton, Steamer Company #9, had his foot trampled on while leading a horse at the station. He was off duty for 10 days.


October 31, 1915

Pipeman Peter Heyboer, Engine Company #12, sprained an ankle and dislocated a rib after being thrown from the exercising wagon. He was off duty for 10½ days.
